GENERAL

Fetch Automation is committed to protecting your privacy and ensuring that personal information is handled in accordance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs).

This Privacy Policy outlines how we collect, use, disclose and store your personal information when you use our website and services.

WHAT WE COLLECT

We may collect the following types of personal information

- o Any information you provide in our contact or subscribe forms, such as your name and email.
- Non-personal information such as your browser type, operating system and website usage via Google Analytics.

We do not collect sensitive or identifying information unless you have knowingly provided it.

HOW WE COLLECT INFORMATION

We use Google Analytics (GA4) to collect anonymous data about how users interact with our website such as pages visited, time spend on site, geographic location (city-level), referring website, device and browser information. This information is collected via cookies and is aggregated to help us improve website performance and user experience. It does not identify individuals.

We collect personal information directly from you when you fill out a contact form, subscribe to our mailing list, email us or call us.

HOW WE USE YOUR INFORMATION

We use your information to provide and improve our services, respond to your inquiries or requests, analyse website performance and user behaviour.

We use cookies and similar technologies to understand how and website is used to improve functionality and performance.

We use Google Analytics 4 (GA4) for basic tracking and performance measurement. At times we also use Google Ads and remarketing features to display targeted advertisements across the internet. This includes,

- displaying ads to past visitors based on their previous interactions with our website,
- o collecting data through Google advertising and identifiers (e.g. Google Adscookies, GA4 audiences).

These tools may influence how you see ads on other websites or platforms such as Google Search or YouTube) based on your visit to our site.
